## California WIC Branch

The California WIC Program is a nutrition program that helps pregnant women, new mothers, and young children eat well and stay healthy. Generally, WIC is available to low income pregnant, breastfeeding, and postpartum women and children under age five who are at nutritional risk and who are at or below 185 percent of the federal poverty level. WIC authorized vendors may need to contact the state administration or county offices during an emergency if there are insufficient supplies of WIC-approved food items.

David Markell at the California WIC Branch should be contacted if grocers experience difficulties in maintaining adequate supplies of WIC-authorized products during an emergency.

## County Health Officers

In case of an emergency, stores may wish to contact the directors of city and/or county health agencies for local public health information. Store administrators should build a working relationship with county health officers in order to ensure employee and public safety during an outbreak of pandemic influenza. Moreover, while businesses should also be in contact with state officials from the Department of Health Services and Office of Emergency Services, county health officers will likely be more accessible than their counterparts in state departments during an emergency.
