- 100,000 acres grass and brush, 20% contained
- Expected containment: 11/23/18
- 6,453 single residences destroyed
- 260 nonresidential commercial properties destroyed
- Northeast winds diminished in the afternoon, continued low RH
- Moderate to extreme fire behavior and spotting still exists
- Structure threat is ongoing for multiple areas
- 6,453 single residences and 260 commercial buildings have been destroyed
- Neal Road Landfill and Union Pacific Railroad are threatened
- Continued threat to PG&E infrastructure
- Clark, Paradise, and Orino substations are offline
- DWR Diversion dam and power plant are threatened
- Ongoing threat to Saw Mill Peak and Flea mountain lookouts
- Paradise and Magalia municipal water supply threatened
- Damage assessment has begun
- Red Flag Warning still in effect for strong winds and low RH
- State of Emergency Proclamation for Butte County has been declared

Proclamations

- Butte County submitted a Proclamation of Local Emergency for the Camp fire in Butte County asking for CDAA, SBA funding and any Federal funding to assist with response and recovery efforts caused by the Camp Fire
- Acting Governor Gavin Newsom issued an emergency proclamation for Butte County due to the effects of the Camp Fire, which has destroyed homes, threatened critical infrastructure and caused the evacuation of residents.
- Acting Governor Gavin Newsom sent a letter to the President and Federal Emergency Management Agency (FEMA) requesting a Presidential Emergency Declaration for Direct Federal Assistance to support the communities impacted by wildfires burning across the state, including the Camp Fire in Butte County, the Hill and Woolsey fires in Ventura County, the Nurse Fire in Solano County and fires in several other counties, including Lassen and Mendocino.

Evacuations

- Mandatory Evacuations Butte Sheriff estimates roughly 52,000 evacuation area
 - Entire City of Paradise
 - Entire community of Pulga
 - Entire community of Concow
 - Entire community of Magalia
 - Hwy. 32 at Nople Ave. down to the Chico City Limits.
 - Both sides of Oro Chico Hwy. from Durham Dayton north to Estates Dr.
 - Cherokee from Hwy. 70 to the lake south to Table Mountain Blvd.
 - Nimshe Zone, Lower Clark Zone, Lower Skyway Zone, Lower Neal Zone, Upper Honey Run Zone, Carnegie Zone, North Pines Zone, North Fir Haven Zone, South Fir Haven Zone, South Pine Zone, Old Magalia Zone, South Cotelenc Zone, and Paradise Zones 1-14.

- As of 11/09/18 at 1159 hours, CUEA reported 23,135 power outages and 12,000 gas outages.

Health and Medical

- Paradise Irrigation District is advising its customers and first responders to boil water and use bottled water.
- Adventist Health Feather River Hospital, 5974 Pentz Rd., Paradise, is under a mandatory evacuation order.
 - Multiple ambulance strike teams were ordered
 - 55 patients were transported via ambulance to Enloe Hospital, Chico

- Butte County Superintendent of Schools has closed all schools, including charter schools, through 11/23/18.

WEATHER OF CONCERN

Northern California

- Dry with warmer than normal temperatures through next week. Critical fire weather conditions return tonight through Monday morning.
- Wildfire smoke from the Camp Fire kept temperatures cooler over a significant portion of the area on Friday due to blocking some heating by the sun. This is expected to be a factor again today, mainly over the Valley south of Paradise, due to light northerly winds. Poor air quality is also expected.

Southern California

- Santa Ana winds will slowly decrease this morning, then transition to onshore flow this afternoon and evening. Another round of Santa Ana winds will bring warm and very dry conditions Sunday morning through Tuesday.

WEATHER SYNOPSIS BY REGION

NORTHERN CALIFORNIA

- High Risk of Significant Fires Due to Gusty N-NE/Offshore Winds/Low Relative Humidity (RH) Saturday Night through Monday Morning from the Western Cascade-Sierra Slopes to the Coast
- High pressure will continue to produce warm and dry conditions for the next week or more.
- Low afternoon RH (5-15%) and poor overnight recovery (5-25%) will continue into Monday at least. Windy areas west of the Cascade-Sierra crest will be the driest.
- NE gusts to 25 mph on upper slopes in Del Norte County tonight through early Monday.
- N-NE/Offshore winds gusting to 25-35 mph and locally higher from the western Cascade-Sierra slopes to the Coast Range Saturday night through Sunday night. Thus, High Risk of Significant Fire for wind and low RH Saturday Night through Monday Morning from the Western Cascade-Sierra Slopes to the Coast.
- Afternoon temperatures will generally be 5-10 degrees above seasonal normals for the next week with our warmest inland areas mostly in the mid 70s.
- Light to locally moderate N-NE winds will return Wednesday.

SOUTHERN CALIFORNIA

- A couple of troughs from Canada will drop into the Desert Southwest through this weekend. Strong high pressure off the California Coast will move inland early next week and then weaken as the week wears on.
- Northeast winds of 20 to 40 mph with gusts to 60 mph will surface across the mountains and below the canyons and passes of Southern California. These winds will decrease and become light by Saturday morning.
- Northeast winds of 20 to 30 mph with gusts to 50 mph will surface across the mountains and below the canyons and passes of Southern California once again Sunday morning through Tuesday morning. Winds will decrease Tuesday afternoon, but local northeast winds of 15 to 25 mph with gusts to 40 mph will continue through Wednesday afternoon. Winds will be light across the region late next week.
- Widespread single digit humidity along with very poor humidity recovery at night will continue through the end of next week.
- Temperatures will be near normal across the valleys and 5 to 10 degrees below normal across the mountains and deserts through the end of next week. Maximum temperatures will be in the upper 40s and 50s across the mountains and 70s to low 80s in the valleys.

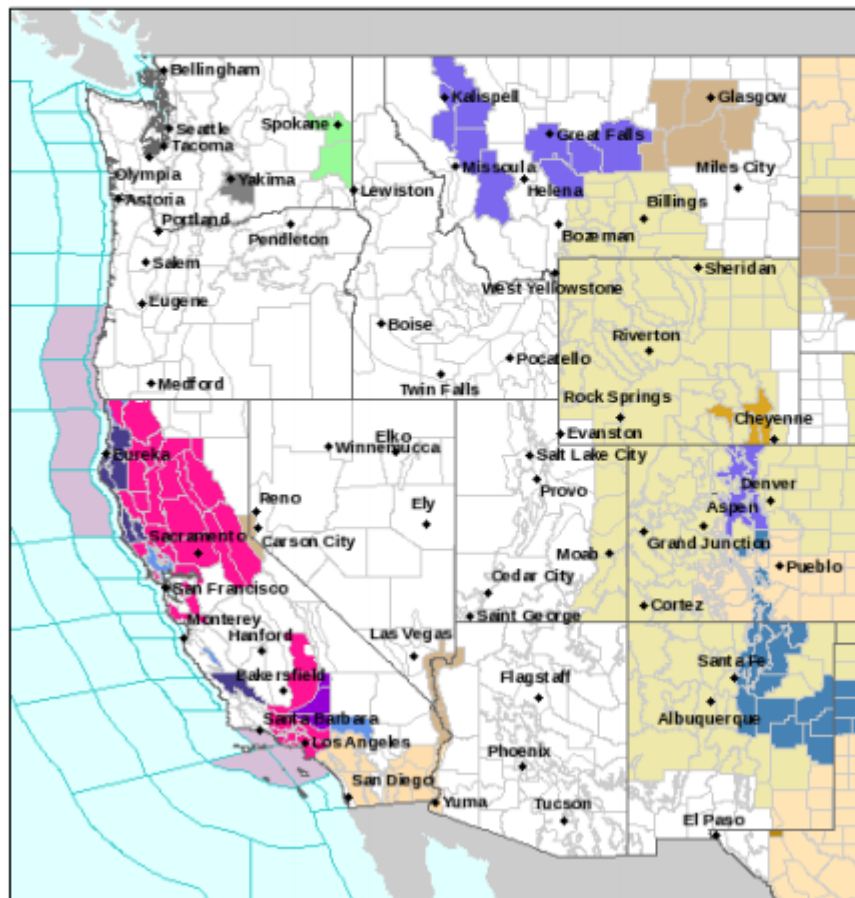
